SECURITY UPDATES



We ask for ALL residents to adhere to the security mandate in the community please.

- 1. Complete the online information for our new security computer system, Gatekey. When having guests visit, please inform security with names of ALL guests via Gatekey.
- 2. If you have not done so, please obtain a decal from the POA office. Residents and homeowners not in compliance will have to use the Service entrance.
- 3. Security passes issued in 2014 for ALL housekeepers, maintenance and contractor workers are expired and 2015 passes needs to be issued from the Security gate. These can be requested in advance via completion through your Gatekey account.
- 4. Security cameras and solar panels have been installed at the security booth to assist with the increase security in our community.
- 5. Due to the implementation of the Immigration policy, the Department of Immigration will be permitted to perform random checks in the community.

COMMUNITY REMINDERS

CONSTRUCTION REMINDERS



1. To ensure we all follow the construction covenants for the community, Charlotteville& Turnberry residents are reminded to obtain written approval from the POA office for both new and addition construction.

 Furthermore, Turnberry townhome residents are reminded to also obtain approval from the POA office for any

changes to the exterior of the townhomes, inclusive of drive ways and back yards. $\,$

- 3. Members with lots under construction please note the following:
- a) The POA office must be notified two (2) days in advance of any heavy equipment. Heavy equipment and or contractors will be denied access for persons not obtaining approval and persons not in good financial standing.
- b) Owners remind contractors to clean up excessive roadside debris and properly dispose of garbage.
- c) Construction deposit has increased to \$2,550.00 (non refundable \$50.00 to provide professional printed Permit Sign) and \$2,500.00 will only be refunded once the Occupancy certificate is received, the building and landscaping is complete to the approved plans and all items confirmed on checklist and signed off by the Committee and POA.
